CABTE has submitted a proposal to the CTC that seeks to amend Bilingual Authorization (BILA) regulations so that all valid, nonemergency credential holders with a major in the language that they are seeking a BILA in may waive the CSET subtest to verify their proficiency in the language. The change would promote equity, reduce financial and logistical burdens for teachers, and address bilingual teacher shortages.
